



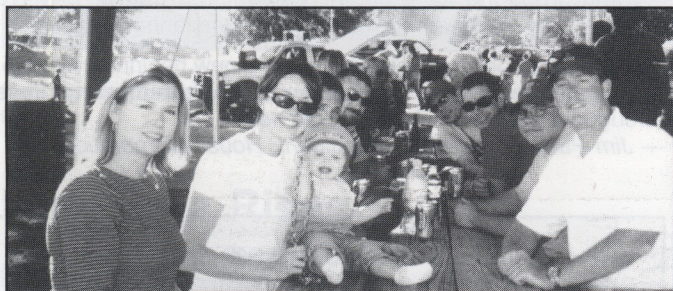

Chapter House Rehab Planned

Dear Brothers: This is an exciting time for Iowa Beta. As you are aware, in February 2004, we formally recolonized at Iowa State. We currently have a colony group of 13 undergraduates who have been working actively with the members of our Chapter Advisory Committee and the Corporation Board to increase membership. We hope to regain our Iowa Beta charter in the fall of 2005.

In March of 2004, following the initiation of the colony, our Corporation Board met in Des Moines. One of the most pressing issues addressed at the meeting dealt with an offer to purchase the house by Sigma Pi, the fraternity that had been renting it for the past five years. The overwhelming consensus of the Board members who were present, in part due to the recolonization effort, was to retain the property. We also decided to update plans for the rehabilitation of the house or for the design and construction of a new house on our current property. Another item of business involved the election of new Corporation Board officers, including myself, Jim Patchett, '71-924, president; Steve Banks, '95-1293, vice president; Lynn Johnson, '57-681, secretary; and Dave Moenk, '71-917, treasurer.

Following the meeting, we arranged for an architect/structural engineer to conduct an updated assessment of the house to determine whether it was still structurally sound and whether it was economically viable to rehabilitate the existing building. This was particularly important in light of the bathroom leakage and associated structural problems that we have had to address over the past couple of years. Following the assessment, which was conducted in May, it was determined that the house was structurally sound.

A second Corporation Board meeting was conducted in Ames on May 16 at the Memorial Union. This provided an opportunity for Corporation Board members to meet the colony members, who were invited to join us. Following the meeting, the whole group visited the house; Sigma Pi was in the process of moving out by this time, as they had purchased another property.

Subsequent to the May meeting and the updated assessment, the Corporation Board agreed to hire RDG Architects and Planners, of Des Moines, to prepare conceptual plans and cost estimates for rehabilitating the existing house versus constructing a new one. A two-day design workshop was held in August at RDG's office. Several alumni and colony members participated in the workshop with a team of RDG architects and building-system engineers. Attendees analyzed a number of alternatives, including the complete demolition of the house and its replacement with a new structure.

Eventually, the design team began to focus on the rehabilitation and expansion of the existing house. This direction was taken, in part, because new construction of similar square

footage would likely cost at least 1-1.5 million dollars more than rehabilitating the existing structure. Obviously, there were other concerns as well, such as maintaining the historical character and heritage of our original chapter house.

Following the workshop session, RDG refined the concepts and prepared a set of conceptual floor plans and graphic perspectives that were shared with alumni and colony members at the Homecoming celebration in Ames on October 9.

Speaking of the Homecoming celebration, it was great to see so many alumni brothers in attendance! We rented a tent on Victory Lane north of the stadium to host the Phi Psi gathering, and everyone seemed to really enjoy the event. There was a great deal of enthusiasm among the more than 70 brothers, colony members, family, and friends who attended the event.

One of the most exciting moments for me personally, however, occurred earlier in the day. Prior to the celebration at the tent, we conducted a Corporation Board meeting at the house. When brother Moenk and I pulled up in front of the house at 12:30 PM, there were already about 30 alumni and colony members standing on the front steps. The meeting offered an opportunity for us to speak with the colony members, to review the conceptual rehabilitation plans for the house, and to hear about plans for a capital campaign.

Other items of business addressed at the Homecoming meeting: the number of corporation board members was set at nine. Then, those present formally elected five additional board members. In addition to the four officers listed above, current board members include Dave Carlson ('62-758), Lynn Seiler ('66-823), Glen Breuer ('73-951), Lance Stahl ('87-1201), and Doug Bywater ('96-1302). Thanks to all of the Corporation Board members for offering their time and expertise at such an important time for Iowa Beta. I want to offer special thanks to Lynn Seiler, who has taken on the direct role of coordinating much of the transition, closure, and ongoing oversight activities with the house.

Following the meeting, everyone toured the house. It was a great feeling to walk through the halls and rooms. It certainly brought back fond memories, and I enjoyed listening to the many stories that were being shared by the brothers.

Prior to moving forward, I think it is important to reflect for a moment and offer our appreciation to our immediate predecessors on the Board. In particular, we thank Ross Stafford ('70-906, president), Doug Fuller ('74-989, treasurer), and Lynn Seiler ('66-823), along with all of the corporation board members who coordinated the lease with Sigma Pi, and kept the doors open, the foundation from caving in, and the checkbook in the black over the past five years.

Since Homecoming, we have continued to evaluate and refine plans for rehabilitating the house. Our colony members have been helpful in providing additional input on various layout options, particularly with respect to preferences for study, sleeping, and restroom facilities. A group of us met again with RDG architects in Des Moines in early November. We discussed various options that would lower the construction costs, as well as accommodate, if necessary, a two-phase construction pro-

gram. We are currently reviewing revised floor plans, and we hope that updated floor plans will be available for review on our new Web page in the near future.

One last thought before closing. Our 80-year-old chapter house, while structurally sound, is in very poor condition. The successful restoration of our chapter at Iowa State makes it necessary that we provide our undergraduate members with competitive housing. This will no doubt require contributions of time and money from many of our alumni brothers. It will also require someone to step forward and lead the effort. For this latter need, we already have brother Bill Good ('69-864), who has spent countless hours on the phone and the road organizing and preparing for a capital campaign. Thanks, Bill! We wouldn't be very far along without your substantial effort.

That's all for now. Best wishes for a new beginning in 2005. Remember the words that we all have shared many times throughout the years: Live ever, die never.

In early spring 2004, the national office of Phi Kappa Psi began a campaign to recolonize at Iowa State, the chapter house having shut its doors in 1999. The campaign was headed by Director of Extension Eric Parker (Iowa Alpha) and Educational Leadership Consultant Ben Nicol (Indiana Epsilon). Brother Parker and brother Nicol initiated six young men as founding fathers of the Iowa Beta Colony in mid-spring.

This core group worked diligently this past summer recruiting incoming students. Our latest initiation in November included five pledges. With their initiation, the colony has more than doubled in size to a strength of 13 members.

In late November, our colony began its elections for the 2005 year. Brother Calvin Truong was re-elected as GP and aspires to have the colony rechartered in 2005. I, Joe Ogrin, was elected VGP; I plan on introducing effective programs within the colony. Brothers Ryan Seth and Justen Jones were elected as our new recruitment chairs. They are creating recruitment plans and goals for the coming year.

Greek Service and Scholarship

Take a trip to Ames, Iowa, and I'll tell you what you'll find. The Zodiac, the Campanile, as well as Sir Lancelot and Elaine will offer warm welcomes; they're not quite as they were years ago, but no less friendly. A short walk south of our campus will find you in the heart of the Iowa State University Greek community — 28 fraternities and 14 sororities. Let's take a closer look at what's going on in Greek life at ISU.

The Dirty Open volleyball tournament, Goreville Manor, and Run for the Roses are but a few of the philanthropic events hosted by ISU Greek chapters. You can't blink twice without receiving an invitation to a benefit of some kind. Greek community members are also involved in other philanthropic activities

in the ISU and Ames communities. To name several, there are blood drives, events to help the Ames Boys and Girls Club, and a dance marathon. In 2003, the local Greek community contributed more than 9,000 hours to community service and raised more than \$63,000 for various organizations.

The ISU Greek community is a wellspring of leadership. Members are involved in key positions all around campus, including spots on the Business Council, the Engineers Week Central Committee, and in various programs within the office of admissions. Many Greeks are also involved in student body government; the current president is a member of Alpha Gamma Delta sorority.

Greek life provides abundant opportunities for extra-curricular activities, but scholarship always comes first. In the fall of 2003, 16 fraternities had grade point averages above the all-men's average, the best group average being 3.49. Eight sororities had grade point averages above the all-women's average, with a high of 3.17. The all-Greek average was 2.92.

The Iowa State Greek community has much to be proud of. Many of its chapters are the best in their respective organizations. Its members find success not only within the Greek system, but also on campus in both academics and extracurricular activities. 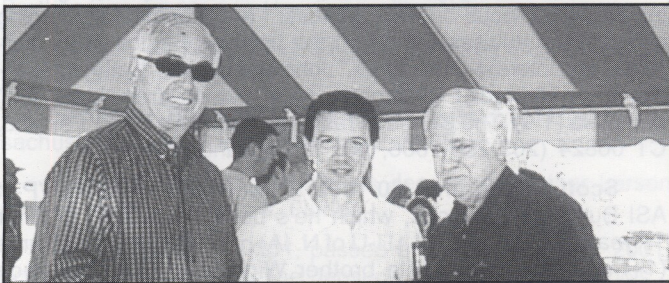

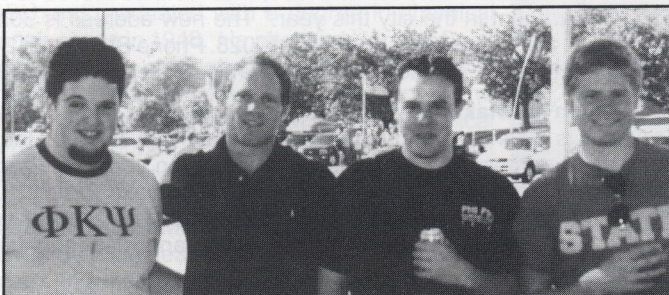
